ORDER FORM & INSTRUCTIONS – CHAMINADE CHARLIE & CHOCOLATE FACTORY

Introduction:

The “CHARLIE” production stills are ready for your viewing on my website www.janetfishmanphotography.com. You may also view them at my place where you can see larger images on my computer (please call 818-349-3439 to set an appointment).

1. PRINT out the below order form and instructions completely. It consists of three pages. **DO NOT** use the “buy your print online” link. **Use only this paper order form to order the production stills.** From time of receipt, it will take between two-four weeks for the orders to be completed. Orders will be accumulated and delivered in bulk to either Sonja Knaack or the school.
2. Complete this order form in its entirety. Please PRINT clearly.
3. Please WATCH which number you write on the order form. Use the SECOND, FOUR-DIGIT number. Example: “Image 9-Img_5236.JPG”. It is the second, FOUR digit IMG/JPG number 5236, **NOT “Image 9”**.
4. Mail the order form and payment to the address indicated at the top of this form. Make checks payable to: Janet Fishman.
5. 4x6 pictures = \$4.00 each (matte finish only)
5x7 pictures = \$8.00 each (matte finish only)
8x10 pictures = \$16.00 each (matte finish only)

Viewing Instructions:

1. Go to www.janetfishmanphotography.com; click on ORDER tab; click pink link to images
2. Click on the pink link to **CHARLIE** images
3. Click on “Main Menu” on the black line above a picture. Then click on Open Menu. Then click on my name, Janet Fishman.
4. When you click on the links to the casts, you will see proofs of the photos. These have not yet been color-corrected. On your computer screen, you may see variations in color, or the proofs may appear dark or off-color. This is due to different computer monitor calibrations. This difference will be corrected during the printing phase. Slight adjustments and cropping may occur at the time of printing and at the discretion of the photographer.
5. Use the arrows on the bottom black line to move through the pictures. Suggestion: keep “thumbnail on” on the lower right box until you see a picture that you are interested in. Then click on the picture. Then click on “open in popup” which is the furthest right button in the lower right toolbox. When done, close popup picture and return to all images by clicking on “thumbnail” box again.
6. Remember not to get confused by the two numbers on the images. See #3 above under Introduction section.
